#### **Upcoming General Election - Exercise Your Right to Vote!**

The November 8th general election represents a chance for us to exercise one of our most basic rights . . . the right to vote. Your vote in favor of Life is critical! Every vote matters, and in mid-term elections, when participation tends to be lower than presidential elections, your vote takes on added significance.

All indications are that Pennsylvania may well decide whether our next Congress is pro-life or not. The pro-abortion forces have made our state a focus of their strategy for maintaining their current congressional majority . . . we cannot let this happen.

At the state level, we have the opportunity to elect a pro-life governor. Our pro-life state legislature has been stymied these past eight years by Governor Wolf. Now that Roe is history, the importance of having a friend of life in the state's top spot is magnified.

This newsletter contains the positions on life issues of those running at the federal and state levels, per the Pennsylvania Pro-Life Federation and LifePAC. Please know where the candidates stand and then exercise your precious vote. The unborn are depending upon you!

Important dates with respect to the election include:

- October 24th last day to register to vote.
- November 1st last day to apply for mail-in or civilian absentee ballot.
- November 8th last day for county boards of elections to receive voted mail-in and civilian absentee ballots (must be received by 8pm).
- November 8th general election in-person voting (7am to 8pm)

#### Voting with a Clear Conscience

Fr. Frank Pavone of Priests for Life has come up with 10 steps to assist citizens in voting with a clear conscience:

- 1. **Vote!** Make sure you actually vote: voting is a moral obligation. 5.
- 2. **Know the candidates.** Be sure you know where the candidates stand on the issues.
- 3. **Reject the disqualified.** A candidate advancing immoral policy positions is disqualified from public office.
- 4. **Distinguish policy from principle.** Often, candidates have different policies for pursuing the same principle. But on life issues, today's candidates differ on principle: whether unborn life is worthy of protection.

- 5. Weigh other issues properly. Not all issues are equal . . . life issues are paramount.
- 6. Keep your loyalty focused on Jesus.
- 7. **Remember, the Party matters.** Elections put both individuals and parties into power. Both have positions on life.
- 8. **Distinguish "choosing evil" from "limiting evil."** Choosing the lesser of two evils is preferable to not voting. After all, one of the two *will* be elected.
- 9. Support the candidate with more than your vote.
- **10. Mobilize other voters.**

#### **Post-Dobbs Developments**

Since the U.S. Supreme Court struck down Roe in the Dobbs v. Jackson case on June 24, 2022, there have been continuing developments on the subject of abortion.

#### The Good News

LifeNews.com reported on Aug. 24, 2022 that

- 13 States are now abortion-free.
- 62 abortion businesses have been closed.
- Thousands of babies' lives have been saved.

#### The Bad News

- Pharmacists are being forced to provide abortion pills The Biden administration has warned pharmacies that they will be liable under federal anti-discrimination law if they do not provide abortion-causing drugs.
- Biden signed an executive order to allow Medicaid monies to help women pay for travel between states to get an abortion.
- Governor Tom Wolf has filed a lawsuit with the PA Supreme Court, declaring that there is a right to abortion in PA. This lawsuit is an attempt to block the PA Life Amendment, which is being pursued in the PA Legislature.

#### Pennsylvania March for Life

We wish to thank all those who traveled to the PA March for Life in Harrisburg on September 19 – and all those who donated to help defray the cost of the buses. Two buses from Butler County traveled to the March: one from Cranberry and one from Butler City, which also stopped in Middlesex Twp.

There were an estimated **6,000** people at the Rally and March. Many of our Butler County legislators attended and participated in the Rally. The following day there was a Planned Parenthood Rally in Harrisburg; photographs showed about **80** people attended that Rally!

We were blessed with beautiful weather and energizing speakers. A mobile ultrasound unit was parked next to the stage during the rally. A woman who lives in Harrisburg came to the unit and asked for an ultrasound, saying she was not sure if she was pregnant. The ultrasound showed she was 17 weeks pregnant. She asked for prayers and an appointment was made for her with a local pregnancy help center for the next day. What a perfect testimony to the Pro-Life work that we are all doing!

Our work in Harrisburg will continue, now that the US Supreme Court has said that abortion decisions can be regulated by the states. We need to continue to elect Pro-Life Senators and Representatives in PA, as well as a Pro-Life Governor!

#### National March for Life


#### WHAT ABOUT FORCING RELIGIOUS GROUPS TO PAY FOR ABORTION?


